

Why Do We Invest? What Is Investing?

Inflation – The Silent Killer

A Wake-up Call



Inflation: The rate at which prices increase over a period of time. Translates to the overall rise in cost of living and leads to a decrease in the value of money.

The Time Value of Money: a dollar today isn't worth a dollar tomorrow. Money loses value over time, therefore, a sum of money now is worth more than in the future. If you defer payment to a future date, you incur an opportunity cost.

Hedging against inflation: Knowing that the value of your money erodes over time if left unattended, investors seek to hedge against inflation by allocating their wealth into investments that protect and grow their wealth.

Interest rates: governments can affect inflation by modifying key economic variables such as interest rates. Interest rates affects the speed at which the economy runs, which ultimately increases or decreases inflation.

Investing Goals

#goals

Depending on your age, risk profile, needs and wants, you can determine an investing goal in the medium or long term. Everyone has some sort of an investing goal whether precise or not.



Having a roof over your head is certainly one of the most important life milestone one could achieve and consistently investing for it over a period of time will let you have the house of your dreams.



Retiring is also an event you would like to plan for and anticipate the amount of capital you need to retire comfortably. Very far away time horizon.



Having a cushion for life events is always good to have and consistent investing will lead to feeling safer and less stressed.

5 years: The minimum amount of time for a financial goal to be considered investing.

Things to keep in mind when designing your investment goal:

- How long do you want to invest for?
- Is your goal quantifiable, do you know what you're going to use the funds for?
- Do you want to invest a one-time lump sum or contribute to your investing account more regularly?
- Are you confident in choosing your own investments, or do you need a financial advisor?
- Is your goal reasonable enough?

Investing vs. Trading

What's the difference?



INVESTING

Investing is the act of allocating money across different investments, with the expectation of generating an income or profit where the gains are larger than losses.

Investing is a long-term activity, where you hold your assets for the long run and expect them to appreciate in value. Think of it as buying and holding.

Decisions are based on the long term and fundamental values of the company.



TRADING

Trading refers to the buying and selling of stocks over shorter time horizons.

Most decisions are based on speculation and to exploit mispricing in the market. Traders rely on mathematical equations and computer algorithms to make their decisions.

Trading holds a higher level of risk and is characterized by more frequent transactions.

The difference between both strategies lies in the execution. Both investing and trading have varying schools of thought within their respective groups






